at the South west Corner of said meadow thence Ertenty  
By the uplans of Ebenezer Crosby or as the fims  
New Stand to the widow Jerusha Hulls meadow thence  
Northly By the widow Jerusha Hulls meadow till  
it comes to the Brook River thence up <sup>westly</sup> stream  
it comes to Ebenezer Crosbys meadow thence Southly  
By Ebenezer Crosbys meadow to the first mention <sup>or</sup> Bound

To have and to hold the same to him the said Micah  
Chapman to him and his Heirs to his and their proper uses  
& behoof for ever & I the said Barnabas Crosby & mehetable  
Crosby his wife for our selves our heirs Executors Do Covenant  
with him the said Micah Chapman his Heirs Executors that we

all Inimberances that we have good Right to Convey the same  
to him the said Micah Chapman his Heirs and assigns for ever

by set our hands & Seals this Seventeenth Day of December one  
thousand Seven Hundred & Eighty Nine Bar
